R v N - Defence - 15 year old charged with large scale arson.

R v Miah - Defence - Police officer charged with misconduct in a public office.

R v B - Defence - Solicitor charged with indecent assaulting 9 year old daughter of a client.

R v Reese & Bennell - Prosecution. Murder of child.

R v Ward, Ward & Ward - Prosecution - Large scale conspiracy to murder.

R v M - Prosecution - Rape by mothers boyfriend on 12 year old girl.

R v Johnson - Defence - Large scale trading standards case.

R v Loader - Prosecution - Attempted murder, suicidally depressed wife drove car at husbands lover.

R v Tymon - Defence - S18 GBH where victim was left permanently disabled after being violently assaulted by 3 defendants, then left in the road where he was run over.

R v Fisher - Prosecution - Doctor charged with manslaughter.

Dr S - Performance - Inappropriate prescribing to drug addicts. Appealed to Privy Council.

Dr E - Performance - Inappropriate prescribing over the internet.

Dr S - Performance - Consultant gastroenterologist failing to adequately supervise an ECG, patient collapsed and died.

Dr M - Conduct - Psychiatrist having inappropriate relationship with patient.

Dr E - Conduct - Dr alleged to have indecently assaulted 13 year old girl whilst patient in ward.

Dr M - Conduct - Dr practising as GP after returning from India, not appropriately qualified or registered.

Dr G - Conduct - Dishonestly claiming memberships of medical associations in advertising brochures and personal profiles handed to potential patients.

Dr C - Repeated dishonesty in job applications/training contracts.

Dr N - GP offering inappropriate advice re: a baby at an out of hours centre.

Dr M & Mr H - Consultants charged with poor treatment/supervision/record keeping.

Dr A - Pathologist makes inappropriate comments in court reports, not backed up by clinical evidence.

Dr B - Issuing false sick notes, allegation of dishonesty.

Dr D - Inappropriate conduct in treatment of dying patient on diamorphine pump.

Dr B - Dr accused of assaulting patient in hospital.

Dr E - Dishonesty in relation to claims expenses and study leave.

Inquests

Sgt Cunningham & Others - Representing several officers including custody officer when a female prisoner died of an overdose after drugs raid.

Sgt Mutch & Others - Female police officer committed suicide. Blame cast at male colleagues in firearms unit. Coroner accepted not an article 2 case.

Sgt X and others - Male prisoner died whilst awaiting booking into custody during 30 minutes delay, could have been taken straight to hospital. Article 2 inquest.

Sgt Patterson - Complex death in custody inquest.
