SPECIALISATION

- Upper limb disorder from use of staple gun at work Irwin Mitchell, Leeds
- Numerous deafness cases involving elderly Claimants where no measurements of noise levels and employment many years ago eg Legal Gateway Solicitors, Eccles, Salford
- Services claims for non-British Coal VWF claims Shaw & Co, Doncaster

I have advised in several hundred British Coal Respiratory (Chronic Bronchitis, COPD and pneumoconiosis) cases and some VWF scheme cases. Have appeared in the High Court at British Coal hearing for Claimants. Provided advices for British Coal offers for Protected Adults, for settlement of proceedings.

CLINICAL NEGLIGENCE

Cases have included failure to diagnose scaphoid fractures, macular degeneration, slipped femoral epiphysis in child, failure to diagnose Crohn's disease, breast cancer and herpes simplex encephalitis.

The CICA cases which I have been involved in have included a number of sensitive cases for local authorities on behalf of children (now in care) who have been sexually abused, including where it has been inappropriate to call them as witnesses. Also police officers (instructed by Russell Jones and Walker, Manchester) and nurse subject to assault at work (instructed by Royal College of Nursing, Bolton).

INQUESTS

Include many mesothelioma, asbestosis and lung cancer deaths. Also suicide for young woman in presence of police officers (Russell Jones and Walker, Manchester); Also death of a senior doctor under extreme pressures from media as a result of professional standing in the community – (Pannone, Manchester); nurse alleged to have neglected patient (Royal College of Nursing).

PROFESSIONAL REGULATION

- Finding of no impairment for Registered Nurse accused of having hit a patient Royal College of Nursing, Bolton
- Overturning of CQC (Care Quality Commission) refusal to register foreign-trained nurse as Care Home Manager by Care Standards Tribunal -Royal College of Nursing, Bolton.
- Nurse admitted to failing to follow prescriptions for babies in Paediatric Intensive Care Unit Royal College of Nursing, Sunderland
- Dentist charged with fraud maintaining of permission to practice for NHS during course of police investigation Pannone, Manchester

OTHER GENERAL COMMON LAW

Especially other contractual and tortuous cases. Also, health and safety prosecutions of businesses especially for food hygiene issues. Successful cases have included:
