



## CRIMINAL LAW UPDATE THE CORONERS AND JUSTICE ACT 2009


The Coroners and Justice Act 2009 provides significant changes in the law governing witness anonymity and partial defences to murder. We shall focus primarily on these aspects of the new Act.

- ◆ The law surrounding the contentious topic of witness anonymity has been fast-moving since the Court of Appeal's decision in the landmark case of R v Davis [2008].
  The Criminal Evidence (Witness Anonymity) Act 2008 a knee-jerk reaction to the Court's decision in Davis has been repealed to a large extent by the Coroners and Justice Act 2009. We shall be looking at the circumstances in which witness anonymity orders can be made; what needs to be done to satisfy the criteria, and the practical implications of the new legislation.
- ◆ The new Act also abolishes the common law/statutory defence of provocation and amends the law on diminished responsibility. We shall look at the new partial defence to murder of "loss of self control" its definition and its application and the amendments to s.2 of the Homicide Act 1957.
