# Alex Leach QC

Call to the Bar: 2001 Oueen's Counsel 2021

Prior to taking silk, Alex sat on the level 4 CPS panels for Serious Crime, Fraud, Confiscation, Rape and Sexual Abuse and Counter Terrorism. Alex also conducts an appellate practice, dealing recently with conviction appeals relating to historic convictions.

Alex also sits as a Recorder (Criminal) and is authorised to try serious sexual offences.

## Murder and Serious, Organised Crime

**R v A,B,C & D** – Alex is instructed in the leading Operation Venetic case, in which evidence acquired by international law enforcement, from the encrypted EncroChat network is relied upon. The investigation was described by the Home Secretary as "a game changing moment in our fight to tackle serious and organised crime". Legal argument concerning the application of the Investigatory Powers Act 2016 (IPA) led to a ruling by the Lord Chief Justice that broke new ground when considering the scope of IPA. The case is ongoing.

 $\mathbf{R} \mathbf{v} \mathbf{G}$  – Alex is instructed as Queen's Counsel in this case, which arises out of an NCA investigation into an alleged hitman, engaged by those involved in serious organised crime to conduct acid attacks and firearms offences in Merseyside. The case relies upon data recovered from the EncroChat networkand is ongoing.

**R v Molnar** – Alex represented (together with Alistair Webster QC) a 17-year-old boy, prosecuted for the murder of Manchester Grammar School pupil, Yousef Makki. The case commanded enormous national attention owing to the sensitivities connected to the prevalence of youth knife crime and the privileged background of the defendants.

**R v Sayers and others** – Alex was instructed in a conspiracy to murder before the Central Criminal Court, involving the shooting of a doorman at the Tup Tup Palace nightclub in Newcastle. The case was transferred to London, from Newcastle, where the principle defendant had, for decades, been the subject of substantial media attention, for his alleged connections to organised crime.

**R v Tuan Anh Do and others** – Alex was instructed as leading counsel in a series of NCA prosecutions for people trafficking, modern slavery and cannabis farming allegations. The case involved the deployment of an undercover officer and relied upon the combined efforts of international law enforcement.

**R v D and others** – Alex was instructed as leading counsel to represent a principle defendant in a large-scale firearms and drug trafficking conspiracy, involving the alleged supply of firearms and cocaine from the North-West, to the East Midlands. The case relies upon evidence acquired through covert monitoring techniques and is ongoing.

**R v McGivern** – Alex represented (together with Simon Csoka QC) a young man prosecuted for the murder of a local rival in Salford. The case engaged complex issues of hearsay and character.

**R v Berryman** – Alex represented a defendant charged with firearms offences in a prosecution brought by North West Regional Organised Crime Unit and based in alleged gang activity in South Manchester. The case turned upon a challenge to the complex, mixed DNA profile evidence relied upon by the prosecution.

### Fraud

R v B,B,F and others – Alex is instructed as Queen's Counsel in a 10 handed HMRC and Insolvency Service prosecution. The case involves allegations that defendants constructed a complex network of businesses, with the sole intention of conducting a wholesale exploitation of the VAT regime.

# Alex Leach QC

**R v Bone and others** – Alex was instructed as leading counsel to represent a defendant charged with orchestrating a multi-investor property portfolio fraud. Alex led a team comprised of junior counsel, specialist fraud solicitors and a forensic accountant in their detailed examination of the enormous volume of material relied upon by the Department for Business, Energy and Industrial Strategy

**R v Hassan Butt** – Alex was instructed as leading counsel in an eBay and international gold bullion prosecution, brought by the Counter Terrorism Division of the Metropolitan Police. The case involved a complex series of interconnected fraud allegations, centered around a trading entity operating through the eBay platform

 ${\it R} {\it v} {\it L} {\it and} {\it J}$  – Alex was instructed to deal with this mortgage fraud and money laundering case in which two defendants had fraudulently obtained mortgages enabling the purchase and resale of a network of properties

## Rape & Family Abuse Cases

 $R \ v \ O$  – Alex was instructed as leading counsel in a child sexual exploitation prosecution involving 11 complainants in Rochdale. The case turned on the review of a substantial volume of social media material and involved the sensitive handling of child complainants with complex backgrounds.

**R v CH** – Alex was instructed to defend a man who had, unknowingly, engaged in sexual activity with ah child, whom

 $\mathbf{R} \mathbf{v} \mathbf{N}$  – Alex was instructed in this case which involved allegations of child rape, assault and sexual abuse of three different children spread across two different families. The case involved a great deal of material from social networking sources.

 $\mathbf{R} \mathbf{v} \mathbf{P}$  – Alex was instructed in this case which involved two complainants and allegations of child rape, sexual assault, abduction, grooming and enforced prostitution over a period of more than a decade.

 $\mathbf{R} \mathbf{v} \mathbf{N}$  – Alex was counsel in this case involving allegations of child abduction and sexual activity with a child. The complainant suffered from extreme learning difficulties and her evidence had to be given with the assistance of an intermediary.

 $\mathbf{R} \mathbf{v} \mathbf{M}$  – Alex was instructed in this case involving allegations of sexual abuse by one child of another within a family setting.
