Pacific Computers - Successful reclaim action in Tax Tribunal.

iSoft - Successful defence of former FD of Footsie company charged with inflating trading figures through over-aggressive revenue recognition policies.

Public Law:



Alistair has presented cases on behalf of the CCRC and regularly advises in relation to prospective appeals.


REGULATORY WORK
