**R v MH and JB** – Gross negligence manslaughter (haulage industry)

R v TLM Ltd and HR - Gross negligence manslaughter (construction industry)

**R v SR and RJ Brown Ltd and others** - Corporate Manslaughter and Section 2 HSWA (construction industry)

**R v CS Ltd and others** – Gross negligence manslaughter and Section 2 HSWA (construction industry)

**R v CB Ltd** – Food Safety Regulations - Defending company directors in relation to deaths from Salmonella infection

**R v MR Ltd and another** - Section 3 HSWA and Causing Death by Dangerous Driving. Prosecution of major bus operator and bus driver arising out of death of a passenger and pedestrian.

## **Financial Crime/SFO**

**R v GM** – Defence of company director in SFO prosecution. Prosecution relates to the operation of the largest installer of solar panels in the UK. Alleged involvement in fraudulent off-shore (Belize) investment scheme involving customers' funds (VHCC Case).

**R v CB ('Euribor')** – Defence of senior Barclays employee for Conspiracy to Defraud. Alleged manipulation of the Euribor index and Euro FX markets. Subesequent appeal to Court of Appeal on proper scope of the offence Conspiracy to Defraud and on jury irregularities (reported at [2020] EWCA Crim 1662).

**R v NJ and others (Op Middlebreaker)** - Prosecution of former Pakistan international cricketer for corruption (match fixing).

**R v NJ** – Defence of solicitor in multi-handed mortgage fraud case involving expert evidence on conveyancing practice.

**R v M** – Successful defence of pensions consultant charged with conspiracy to defraud (VHCC Case).

*R* (*Qualter and others*) *v CWAC* [2020] 1 *WLR* 1073 - Power of local authorities to conduct a fraud investigation (a regional trading standards investigation into sale of energy contracts)

**R v Khaliq and others** - Trading Standards prosecution of operators of rental agency for multiple frauds involving clients (landlords), tenants and insurers.

#### **Serious Crime**

R v MO & others (Operation Tradite North 2) – Importation of class A drugs (ongoing), Manchester Crown Court. Case involving 25 defendants, three trials (each with an estimate of around five months), over 100,000 pages of served evidence. Importation of drugs with potential street valuation in excess of £2 billion. Instructed by the International Justice and Organised Crime Division (IJOCD) of the CPS.

**R v Cornett & others** – 6 month trial at Liverpool Crown Court. Prosecution of members of Liverpool gang for distribution of drugs across North West, Yorkshire, South Wales and South West England. Principal organiser sentenced to 24 years imprisonment. (Appeal reported as R v Michaels [2020] EWCA Crim 1450).

**R v N & Others** – Prosecution of 8 defendants in conspiracy to import £14 million worth of cocaine organised by a serving prisoner at HMP Kirkham

**R v A, B & Others** – NCA prosecution of mixed UK / Latvian / Russian organised crime group for conspiracy to import cocaine and heroin into the UK. Case involving anonymous evidence from Belgium special forces who undertook surveillance.

## Other Homicide

Andrew Thomas has prosecuted and defended in more than 60 cases of murder and manslaughter, ranging from domestic killings to gangland shootings.

*R v Daniels and others – Successful prosecution of murder by firearm arising out of drugs dispute. Appeal* to Court of Appeal on issue of withdrawal of defence counsel mid-trial on grounds of 'professional embarrassment'. (Reported at [2021] EWCA Crim 2021).

R v SC – Successful defence of man charged with murder of wife's lover after the Defendant arrived home to find stranger fleeing from his house.

- **R** v NB Successful defence of University student charged with her boyfriend with drug-related murder.
- **R v HG** Successful defence of school secretary charged with murder by arson of her partner.
- **R v SH** Successful defence of babysitter charged with murder of two year old child.
- **R v CJ** Prosecution of mother for manslaughter of 8 month old baby by suffocation.
- **R v SG** Prosecution of father for manslaughter of 4 month old baby.

**R v DN** – Defence of stepfather for murder of 15 month old child; causation issues.
