**R v JTF Wholesale Ltd - Stafford Crown Court 2017** – Section 3 HSWA. Prosecution of retail company in respect of an outbreak of Legionnaire's Disease. Spread of disease caused by failure to implement proper maintenance and cleaning regimes for displays of hot tubs in a chain of superstores. Outbreak in Stoke on Trent resulted in 2 deaths and 19 other cases of serious illness.

**R v SR and RJ Brown Ltd and others** - Manchester Crown Court 2017 – Corporate Manslaughter and Section 2 HSWA. Construction and Demolition. Employee killed in fall from a roof at a quarry.

**R v M Ltd** - Birmingham Crown Court 2017 (ongoing) – Section 3 HSWA and Dangerous Driving. Prosecution of major bus operator and bus driver arising out of death of a passenger and pedestrian.

**R v C Smith & Son Ltd, Thompson and others** - Manchester Crown Court 2016 – Manslaughter and Section 3 HSWA. Construction and Demolition. Employee killed in fall from a roof at a demolition site.

**R v CE Ltd** - Bradford Crown Court 2016 – Section 3 HSWA. Hotel business. Collapse of balcony causing serious injury to three guests and manager.

**R v Baldwins Crane Hire Ltd 2016** – Corporate Manslaughter and Section 3 HSWA. Prosecution of crane operator following the death of an employee due to failing of brakes on a 100 tonne mobile crane.

**R v Bawa Garba and others** - Nottingham Crown Court 2015; Court of Appeal 2016 – Gross Negligence Manslaughter. Prosecution of hospital doctor and two nurses for grossly negligent treatment of 2 year old child, resulting in death. Conviction upheld on appeal. Reported at (2016) EWCA Crim 1841.

**R v Pyranha Mouldings Ltd, Makreth and others** - Liverpool Crown Court 2015 – Corporate Manslaughter and Section 2 HSWA. Manufacturing company. Employee trapped and killed inside an industrial oven.

**Royal Borough of Windsor & Maidenhead v JH** - Reading Magistrates Court – Defence of waste operator in abatement of noise nuisance proceedings.
