R v R – Defence counsel, Rape, S18 Wounding; legal argument re admissibility of first account, vulnerable witness, bad character

R v E – Defence counsel, Sexual Assault; allegation involving vulnerable witness, disclosure issues, s41 YJCEA 1999 application.

R v H – Sexual Assault.

R v H – Defence Counsel, Threats to Kill and Assault. Background of alleged forced marriage, domestic violence.

R v D and M – Prosecution Counsel, Robbery.

R v R – Prosecution Counsel, multiple burglaries.

R v P and others – Prosecution Counsel, Conspiracy to commit Immigration offences.

R v H – Prosecution Counsel, Appeal against Sentence, Court of Appeal, invited to assist the Court re relevant case law on SOPOs.

R v O – Defence Counsel, Appeal against Sentence, Court of Appeal.

R v A – Defence counsel, historic allegations of sexual abuse (including Attempted Rape) of children, breach of trust.

RvK – Prosecution Counsel, Wounding with Intent, domestic violence.

R v D and S – Prosecution counsel, a number of armed robberies of off-licences.

R v L EWCA Crim 95: Defence Counsel, appeal against sentence, Court of Appeal, Causing Grievous Bodily Harm with Intent, sentence reduced from 4 years to 3 years.

R v Fordred EWCA Crim 2107: appeal against sentence, Court of Appeal, IPP prisoner case in which A had not been given the opportunity to undertake any Offender Management Work.

R v S & 8 Ors EWCA Crim 3616: Court of Appeal gave further guidance regarding dangerousness provisions in Criminal Justice Act 2003, following case of R v Lang.
