

Louise became a tenant at Lincoln House in September 2011. She practices in criminal, regulatory and civil law, and has experience of personal injury law, clinical negligence and mental health/mental capacity law.

Prior to joining Lincoln House, Louise read Law at Cambridge University before going on to study for an MPhil and PhD in Criminology at the Institute of Criminology at Cambridge University.

Her PhD investigated how judges exercise discretion when sentencing mentally disordered individuals, and how psychiatrists and probation officers exercise discretion when preparing pre-sentence reports. She is consequently very familiar with mental health policy, legislation and case law. She studied the Bar Vocational Course at Manchester Metropolitan University, and was awarded a Commendation achieving the highest mark in the Criminal Litigation exam. She was also the Richard Isaacson Scholar in 2010.

Louise is also a Lecturer in Law at the University of Central Lancashire, and teaches criminal and civil litigation, criminal law and the law of evidence. She is assistant editor of the Archbold Magistrates Courts Criminal Practice publication, a role she has held since 2003, and is sentencing editor of the Archbold Review journal.

### **Criminal Law**

Louise has conducted trials in the Magistrates and Crown Court on behalf of both the prosecution and defence. Shortly after finishing her pupillage, she completed a six-month secondment with the CPS in Manchester during which reviewed cases in preparation for trial and conducted trials in the Magistrates Court on an almost daily basis. She has also completed a secondment with the DWP in Liverpool, during which she reviewed benefit fraud cases to advise on appropriate charges.

Following the secondments Louise returned to Chambers and has been very busy in the Crown Court since then. She is a Category 2 prosecutor, and has successfully prosecuted cases involving serious violence, property offences and serious drug offences in the Crown Court. She has also successfully defended in a vast range of offence groups including cases involving violence, serious drug offences, sexual offences and theft, robbery and dishonesty.

# **Mental Health and Mental Capacity Law**

Louise's interest in mental health law stems from her PhD studies, which examined the treatment of mentally disordered offenders by the criminal courts.

She has a good understanding of mental health law and the work of the Court of Protection through completion of a work placement with Irwin Mitchell solicitors, during which she attended a trial in the Court of Protection concerning the treatment of a young man with autism. Louise facilitated the delivery of expert evidence in what is described as "a concurrent evidence day" in which 9 experts gave evidence together having been taken through an agreed agenda of issues for resolution. The case is reported at [2011] EWHC 1539 (Admin)

### **Clinical Negligence**

Louise has a developing clinical negligence practice. She has advised on liability and quantum in several cases involving injuries sustained after surgery and has acted on behalf of claimants in case management hearings in the County Court.
