

For the first 10 years or so of his practice, Neil had a general common law practice including family, personal injury and largely criminal law. Over the last few years, he has practised solely in crime as it has become increasingly specialised. He has a healthy mixture of both prosecution and defence work.

Neil is a member of the Northern Circuit and of the Criminal Bar Association and is a Grade 4 prosecutor (2007). He also prosecutes theft and fraud for the Post Office.

He deals with cases involving the Serious Organised Crime Agency (S.O.C.A).

**R v Maisha Mohammed** – Rare prosecution of Child Destruction under Infant Life Preservation Act 1929.

**R v Bourke (from 1993)** – Conviction Appeal in the Stockport MOT testers double murder.

R v Brooks – Multiple rapist.

Blair & Ors – Double murder.

Dowie & Ors – Operation Moth, Cocaine factory conspiracy.

*Swellings & Ors 2007/8* – Neil acted for the youngest defendant, aged 15, in the Gary Newlove murder in Warrington, heard at Chester Crown Court, which resulted in an acquittal for his client.
