R v Berry & Others – assault & ill-treatment/neglect of person who lacks capacity – Defence Counsel – care home worker alleged to have “boiled” a patient, causing serious debilitating scald injuries to her legs; then to have covered up the mistake and failed to obtain medical treatment – acquitted (convicted of regulatory offence)

R v Laird – child cruelty & s.20, GBH – Prosecution Counsel – allegations of multiple serious assaults to 8-week-old baby

R v Zubar – violent disorder – Defence Counsel – 10-handed violent disorder arising out of Asian extended family dispute – acquitted

R v Buckley – causing serious harm to a child – Defence Counsel – starved daughter almost to death.

R v McMinn – s.18, GBH – Prosecution Counsel

R v Marsh – s.20, GBH – Defence Counsel – assault on the rugby field – privately funded case

R v Hodgson – rape & sexual assault – Defence Counsel – multiple allegations of raping and sexually abusing a teenage boy

R v Hilton – sexual assault of a child under 13 – Defence Counsel

R v Mohan – historic rape of a child under 13 – Defence Counsel – allegations of historic sexual abuse of his natural daughter – acquitted

R v Lord – attempt rape & assault by penetration – Defence Counsel – alleged sexual assaults as against his estranged wife

R v Saeedi – multiple rapes – Defence Counsel – acquitted

R v Butterworth – historic sexual abuse – junior Defence Counsel – privately funded case.

R v Stanley – multiple rapes – Defence Counsel – multiple allegations of sexual assault; multiple complainants – acquitted

R v Higgins – historic familial sexual abuse – Defence Counsel – charged with allegations of historic sexual misconduct against his half-sister from when he was aged 13 and she was only 7 years old – acquitted of attempting to rape her and of repeatedly indecently assaulting her

R v Gabryszewski – rape – Defence Counsel – successfully defended a Polish national who spoke no English

R v Bailey & Others – Operation Kellington – conspiracy to supply Class A drugs – Defence Counsel – Prosecution conceded were unable to prove Class A drugs had been or were to be supplied to/by the Defendant, Bailey

R v Norwood & Others – Operation Heliodor – conspiracy to supply Class A drugs – Defence Counsel

R v Maher – encouraging/assisting the commission of an offence (supply cocaine) – Defence Counsel – unusual offence, contrary to s.45, Serious Crime Act – custodian of 85kg of cutting agents (“bash”)

R v Leighton & Others – Operation Afterburn – conspiracy to supply drugs – Defence Counsel – drugs supply line between Manchester and Portsmouth

R v Deafern – Certificate of Inadequacy (Drug Trafficking Act 1994) – Defence Counsel – granted

R v Shelton – Certificate of Inadequacy (Criminal Justice Act 1988) – Defence Counsel – granted

R v Freeman-Olugbenga & Others – Operation Hook – drugs importation – Defence Counsel – acquitted

R v Marra & Others – Operation Moth – conspiracy to supply cocaine – Defence Counsel

R v Kara – money laundering – Defence Counsel – allegations of cuckoo smurfing

R v Coppell & Others – Operation Binbrook – conspiracy to supply Class A drugs & money laundering – Defence Counsel

R v Dolan & Others – conspiracy to supply cocaine – Defence Counsel

R v McCallin – drug importation – Defence Counsel – HGV driver importing cannabis by the lorry load from Europe

R v Riley & Others – Operation Barometer – Defence Counsel – major conspiracy to supply cocaine across the North West

R v Whitworth & Others – Defence Counsel – conspiracy to supply cocaine from the Midlands to the North West – involved the importation of hundreds of kilograms of Benzocaine from China

R v Tang & Others – Operation Delmas – junior Defence Counsel – conspiracy to supply wholesale quantities of Class A drugs from London to the North West & money laundering

R v Hayhurst & Others – Operation Beath – Defence Counsel – money launderer charged in connection with international conspiracy to import/supply drugs – potential value in excess of £100 million

R v Healy & Others – Operation Rigging – Defence Counsel – large-scale conspiracy to supply drugs

R v Gregory & Others – Operation Perryville – Defence Counsel – 26 Defendants charged out of undercover drugs operation

R v Davenport – theft – Defence Counsel – breach of trust case – executor of a will; stole sister's inheritance.

R v Ogunleye & Others – conspiracy to assist unlawful immigration – Defence Counsel – sham marriages between EU & Nigerian nationals.

R v Thompson & Others – fraud – junior Defence Counsel – million pound conspiracy to defraud elderly people throughout the UK – case against Thompson eventually dropped at trial.

R v Parsons – fraud – junior Defence Counsel – conspiracy to defraud multiple banking institutions – digital interception of credit card details from freestanding ATM units – technology employed never before seen in use in UK – stated to have the potential to cripple UK financial institutions.

R v Holt & Others – Operation Rochefort – Defence Counsel – 14 handed set-top box fraud – represented only Defendant against whom the case was eventually dropped.
