# **Public Law/Human Rights/Immigration**

**O v SSHD** – Unlawful Detention claim Matthew was instructed to draft summary grounds for defence, extension of time application and to defend the case at oral permission hearing and subsequently full substantive hearing. Matthew was successful with each application prior to the substantive hearing and was able to negotiate a settlement prior to final hearing.

**AA v SSHD** – Panel B instructed case relating to classification of whether or not an individual was a victim of slavery and or trafficking. Matthew drafted grounds in defence and represented the SSHD at Oral Permission Hearing.

**SQS v SSHD** – Matthew advised the SSHD on the lawfulness of claims in and outside of the relevant period relating to the Supreme Court case of Hemmati and whether or not there was a successful step created (as identified in the case of DN (Rwanda) in order to exclude liability following the relevant period.

**JK v SSHD** – case relates to 317 days of unlawful detention transferred to QBD. The Claimant was an Adult at Risk level 3 and an EEA National. Case was resolved.

**K v MOJ** – Matthew successfully defending an application before the High Court for Habeas Corpus. The matter is currently pending application before he Supreme Court, Matthew retains instructions.

**MP v SSHD** – Matthew advised government on the adequacy and delay relating to provision of s.95 support accommodation. Matthew defended the application for Judicial Review at substantive hearing.

**M v SSHD** – a claim for false imprisonment and Data Protection Breach, Matthew was instructed to defend the claim and draft extensive pleadings and negotiate at settlement, advising government on issues relating to quantum of damages. Claim related to lawfulness of court orders.

**B v HMRC & DWP** – Matthew represented both defendants successfully in this appeal of a tax decision before the High Court.

**LE v HMRC** – Matthew represented the Revenue in this MTIC fraud hearing led by senior counsel. The hearing took place in the Tax Tribunals over a number of days submissions, and examination of witnesses.

#### Safeguarding

**MG v DBS** – Matthew represented an appellant in the Upper Tier Tribunal on an appeal of a decision to add the individual to the adults and childrens barred lists. He was instructed at first instance, advising at conference, on paper and providing detailed legal submissions. He represented the individual at the final hearing and on matters relating to appeal.

**CO2 v DBS** – Matthew advised and represented the DBS in an appeal to include his name in the adults barred list. This matter relating to professional competence due to the nature of the Appellants work. This case was regarding a professional health provider and the provision of their services.

**DH v DBS** – Matthew represented the DBS in an appeal. The importance of this case at final hearing was regarding error of law, irrational or disproportionate decision making and the legality of errors of law and fact. This individual was a professional working with vulnerable adults.

**SC v DBS** – an appeal relating to inclusion the barring lists for a professional. Matthew took the case on an initial advice regarding grounds of defence. He also assisted in the nature of evidence required at final hearing, advising the DBS on what elements needed further investigation in order to mount a defence.

# Regulatory

**G v HSE** – Matthew defended a building contractor, an individual, throughout proceedings at PTPH through to sentencing. This was s33 offence for two defendants. The case was unique in that there was successful legal argument regarding counts on the indictment. Once this was resolved the case was able to proceed to sentence. Matthew was able to secure a community sentence.

**PJC & C v EA** – This was a Crown Court trial held at Cambridge over three days. Matthew represented the Company and the Director securing an acquittal. The case involved a number of complex issues. There were numerous legal arguments on applications to dismiss, and admissibility of key evidence at the hearing.

**VGM v DVLA** – this was in relation to defence of a charge for fraudulent use of an operators licence. The Case was taken out at half time following the use of the case R v Stringer [2008] EWCA Crim 1222 in submitting that the Prosecution had to establish evidence relating to the state of mind of the Defendant in order to prove intention to deceive. Subsequently, had the case continued after half time the defence was one of acting in good faith and not having an intention to deceive which in this case the Prosecution could not prove on the evidence. The Court returned not guilty verdicts.

**HSE v A & Ors** – Represented the HSE in a case involving asbestos. Prepared the hearing at PTPH, reviewed the indictment and advised on issues relating to bad character/plea.

**CEC v K** – instructed on sentence and POCA in relation to an offender who was selling counterfeit goods and tobacco. He was able to secure a stringent Community Order.

**MCC v MI** – instructed to represent a Taxi Driver who had his licence revoked and lost his appeal in the Magistrates Court. This case involved prolonged argument on the Fit and Proper Person test, including argument on costs.

**R v MM** – represented, on sentence, a disqualified director of a business that went into liquidation. The Director who was disqualified opted to act for the company when its owner had fallen ill.

**SF v OCC** – successfully represented at trial a scrap metal dealer on an appeal against a Local Council regarding a revocation of his licence. This case contained considerable legal argument, as there is very little within the case law that defines the applicability of the Legislation.

**HSE v R Housing** – de facto junior to Ms Roberts on a Section 2 and 3 Prosecution of a Housing Company where a death had occurred due to serious shortcomings by the Company. He drafted a skeleton argument for the Prosecution regarding a reverse burden of proof argument.

# **Professional Negligence**

HOUSE

**Dr C v EL Solicitors** – Professional Negligence against a firm of solicitors who had failed to apply for an extension of a lease. Mr Howarth was instructed to draft an advice on the law and assist with a Letter before Claim including a standstill agreement.

**Dr K** – Matthew was instructed to draft a Letter Before Action and legal argument on a case involving a Limitation Argument where the Claimant did not issue proceedings within the relevant period when there was a severe Mental Health illness.

#### Serious Fraud Office

**SFO** – Instructed across a two year investigation by the SFO as lead review counsel to advise prosecution team on key pieces of disclosure and evidence, both in terms of the quality of the evidence for trial and elements that were not to be disclosed due to LPP.

# **Road Traffic Act**

**DVSA v H** – Represented a company and it's directors at trial for an offence of intending to deceive a transport officer by transferring a Operators License. Succeeded on a submission of no case to answer after the close of the Prosecution case.

 $\mathbf{R} \mathbf{v} \mathbf{C} \mathbf{W}$  – successfully argued special reasons for a medical professional who responded to a medical emergency and exceeded the legal speed limit.

**R v MH** – successfully argued on appeal to the Crown Court that that disqualification of a driver amounted to exceptional hardship. The Driver was a specialist engineer who needed to drive for work and would lose his job otherwise.

**R v TS** – instructed to represent a defendant charged with Death by Dangerous Driving at Bradford Crown Court. This trial involved the death of one older gentleman and the serious injury to his wife.

#### Crime

**HS2** – Matthew was instructed by Government to assist Police and staff members of HS2 on the legal position regarding trespass and criminal offences around train stations and trespass.

 $R \ v \ JD$  – Large Scale Multi-handed Conspiracy to transfer firearms and Class A drugs. Instructed as Junior Counsel for leading Defendant. Review of covert monitoring evidence across four jury trials. Key arguments on disclosure in relation to material unfairly withheld and disputes over PII material and its relevance.

**R v FVG** – secured the acquittal of a renowned footballer who allegedly assaulted a witness in court proceedings.

**R v BWA** – successfully excluded a interview with 15 admissions of guilt under section 76 PACE after a day of legal argument at voir dire.

**R v DH** – mitigated on behalf of a dangerous offender who had mugged a number of people a knifepoint. He was able to mitigate the sentence from a life sentence to a six-year sentence with a extended licence period.

**R v ML** – successfully represented the wife of a defendant in confiscation proceedings. The Police sought to confiscate money that was legitimately acquired from her Hair Styling business.

**R v S** – successful defence of an individual accused of running a cannibas farm. The Court accepted evidence that he was a victim of slavery and he was acquitted.

# **Inquiry Work**

**Independent Inquiry into Child Sexual Abuse** – Matthew was instructed along with a team of barristers to review allegations of abuse against leaders of the Church of England. This involved review of LPP and Public Interest Immunity material.

**Hacked Off** – Matthew was instructed to advise the victms rights group in relation to a Judicial Review regarding a failure to prosecute criminal offences relating to phone hacking.

## **Prison Law**

**HMP Strangeways** – This case involved a number of competing Public Interest and Human Rights arguments both for and against release following a self declared recall. Release was allowed following the hearing and submissions of counsel. The Prisoner was serving a life sentence for murder.
