"Operation Florida" – Multi-Defendant trial involving organised criminal group targeting high value HGV containers to steal contents throughout UK & then distribute gang members. money out of the UK.

"Operation Jamesford" – International fraud & money laundering trial involving 'cuckoo smurfing' to transfer money out of the UK.

R v B – Senior accountant at major high street business charged with accounting fraud.

Drug Offences

R v McIntyre & Others – Acted for lead Defendant in multi handed drugs trial where organised commercial supply of Class A drugs across North of England.

R v Valli & Others – Acted as lead Advocate in highly organised conspiracy trials involving supply of Class A drugs and handling of very high value commercial goods.

R v Pitt – Elderly Defendant charged with causing death of his wife by dangerous driving. Successful defence involving scientific evidence relating to sunlight reflecting off signage.

R v Saddique – Multi-Defendant trial involving gang violence & use of a firearm

R v Roddis – Defendant previously convicted of terrorist offences charged with further offences involving the possession of explosives.

R v Tunstill – Lead advocate for Defence where Defendant charged with murder of new born baby. Trial involved complicated psychiatric evidence and the defences of infanticide & diminished responsibility.

Private Client

R v Mills - HGV driver charged with death by dangerous driving where potential issue over state of vehicle & funded by employer's insurance. Negotiated plea with prosecution to offence of death by careless driving.

R v Vaughan – Senior NHS manager charged with historic child sex offences & child cruelty. After trial, Defendant was acquitted charges save one.
