## Defending

**Manchester Crown Court:** defended a sentence for possession with intent to supply cannabis. The Defendant received a suspended sentence.

**Manchester Crown Court:** defended a man who had pleaded guilty to multiple sexual offences against a child. The Defendant received a sentence of 37 months, despite the offences carrying a starting point of 60 months.

**Preston Crown Court:** successful exceptional hardship argument advanced on appeal on the basis of loss of employment in circumstances where the employer was unaware of the proceedings, resulting in the immediate removal of disqualification.

**Manchester Crown Court:** defended a woman charged with theft of a bank card from a deceased friend. The Defendant received a suspended sentence.

**Manchester Crown Court:** defended a man who pleaded guilty to a racially aggravated assault on a police officer and 6 common assaults, all committed on the same occasion. The Defendant received a suspended sentence.

**Manchester Crown Court:** defended a man charged with causing grievous bodily harm. Successfully resisted the Prosecution application for a Criminal Behaviour Order.

**Preston Crown Court:** defended at trial for breach of a sexual harm prevention order. The case involved technical digital evidence disclosed shortly before trial. The Defendant pleaded guilty on the morning of trial, with a favourable sentence resulting in him walking free that day.
