Inquest Law Update - This seminar will explore emerging legal trends from the Administrative Court and the Northern Ireland High Court, focusing on:

- The evolving scope of Article 2 obligations for public bodies

#### **Mental Health and Work-Related Death Inquests**

The boundaries of what Coroners consider appropriate to include within the scope of inquests continue to expand, particularly in cases involving deaths linked to workplace bullying and stress. As working practices evolve and there is increased recognition of the importance of the 'health' aspect of health and safety, this is becoming a rapidly developing issue and a matter of significant public concern.

This seminar will examine the law in this area, how best to prepare for such inquests, and what future developments may look like.

#### **Inquests for Criminal Practitioners**

Those who undertake criminal work will periodically encounter cases that intersect with a Coroner's Inquest. It is in the interests of both you and your client to have a clear overview of the inquest process.

Hillsborough Law - On 16 September, the Government laid before Parliament the Public Office (Accountability) Bill, commonly known as Hillsborough Law. The Bill introduces a duty of candour and assistance on public authorities and officials in relation to their involvement with public inquiries and inquests. It ensures that families of victims in state-related deaths are able to access non-means-tested legal assistance and advocacy at inquests and inquiries where public authorities are interested persons. It also introduces new criminal offences to replace the existing offence of misconduct in public office.

If enacted in full, the Bill is likely to have a significant impact on public inquiries and a large number of inquests.

This seminar will explore the main features of the Bill and its implications. Given the scope of the proposed changes, this session will be of interest to anyone involved in inquest and inquiry work, from both public-and privatesector perspectives.

## Room 1 Seminar 4: 3.30pm - 4.45pm

Healthcare Inquests – This session will explore the scope of healthcare inquests, including the impact of potential investigations by the Police and the Care Quality Commission (CQC) on care homes and providers. The seminar will examine the role of hospitals, NHS trusts, and maternity units as state bodies under Article 2 of the European Convention on Human Rights, and the associated legal risks. It will also address potential prosecutions under health and safety legislation and the Health and Social Care Act.

Professional Disciplinary Considerations in Criminal Cases – Professional clients facing criminal allegations must be concerned not only about the threat to their liberty, but also about the potential impact on their career, livelihood, and reputation should their regulator commence a parallel investigation. Understanding the interplay between criminal and professional disciplinary proceedings is essential for all those specialising in criminal defence who represent professional clients, in order to provide comprehensive advice and representation.

In this seminar, the speakers will examine the key aspects of professional discipline and regulation, as well as the main considerations for those acting in criminal proceedings — including the risks to be aware of and the opportunities not to be overlooked.

This session is particularly relevant for criminal law practitioners whose professional clients may also face disciplinary proceedings.
